2. The jurisdictional Commissioners are requested to ensure that the officers who have been included in the Agreed/O.D.I. lists, including all the officers against whom disciplinary cases are pending or have otherwise come to adverse notice of the department, are not posted to sensitive charge. The Commissioners from whose charge such officers are transferred out shall immediately provide such information in respect of officers in the above categories to the Commissioners under whose charge the officer is under order of posting.
3. Officers posted to Customs will be allocated Commissionerates by the Chief Commissioner, Customs (Prev.) Delhi.
4. The officers who are involved in election process for General Election, 2019, shall be relieved after electoral process is complete.
5. The jurisdictional Commissioners are requested to issue Intra-Commissionerate transfer /placement orders by 17.05.2019. While doing so, jurisdictional Commissioners may rotate the officers whose tenure in a particular station is complete as prescribed in Para 6.12 of the transfer guidelines dated 17.01.2018. Those officers who have been transferred to Mohali Sub Commissionerate with 'local' against their name shall be transferred only to the Hqrs., Sub Commissionerate Mohali or the following four divisions: 1. Mohali Division-I 2. Mohali Division-II 3. Derabassi Division-I 4. Derabassi Division-II.
6. Officers posted to Directorates on loan/local transfer basis are for an initial period of 2 years from the strength of Chief Commissioner Office, GST, Chandigarh Zone and as per Board's letter dated 16.06.2017, the salary of the above officers, will be drawn from the budgetary head of the CCO & they will not be entitled to any special pay/deputation allowance
7. Officers mentioned at Sr. No. 6, 45, 59 and 103 are not entitled to joining time/ TTA as their transfers are being ordered on their own request.
8. All the representations, received till date, are disposed of accordingly. No fresh representation will be considered unless the officers join their new place of posting.
9. Representation, if any against this order will only be considered if it has been forwarded by the Commissionerate with the express approval of the Commissioner. No "Advance copy"/ direct representations will be entertained.
10. All the officers except falling under the category of Sr. No. 4 above stands relieved w.e.f. 17.05.2019 with the direction to join their new place of posting.
11. This issues with the approval of the Principal Chief Commissioner.
